TERMS AND CONDITIONS

Race to the top-Đường đua Thương đỉnh Terms and Conditions

Race to the top-Đường đua Thương đỉnh (herein the “Promotion”) is a reward offered by HF Markets (SV) Ltd (herein the “Company”) to its Partners under the following Terms and Conditions.

1. Introduction

- 1.1. This Promotion is available to all Partners of the Company who have satisfied the Criteria for this Promotion as set out in paragraphs 1.2 and 1.3 of this Promotion Terms and Conditions.
- 1.2. In order for a Partner to be eligible to participate this Promotion he must have opened an Approved myHF Account with the Company as per the Account Opening Agreement, and he must have completed the age of 18 or the legal age applied in his country of residence or must not be otherwise considered as a ‘minor’ in his country of residence.
- 1.3. This Promotion is available for Partners in Vietnam.
- 1.4. The Partner hereby acknowledges, confirms and accepts to be legally bound by the Terms and Conditions as set out in this Promotion and/or any other legally binding Agreement between him and the Company.

2. Promotion Period

- 2.1. The Promotion period runs from 22nd of September 2025 till 12th of December 2025. The Partner enters the draw by accepting the T&C and trading during the promotion period.

3. Terms and Conditions

- 3.1. New and Existing Partners are eligible to participate in the Promotion.
- 3.2. To be able to enter into the draw the following requirements must be met:
 - The Partner’s wallet must be approved.
 - The Partner to be Eligible to participate in the Promotion, must trade at least 20 standard lots on Forex, Gold, Silver, Coins/Crypto (Pro/Zero account 1/3).
 - The Partner must reach 5 Activated Clients.
 - The Partner must have a cashflow of 5,000 USD.
 - The Partner for every 20 additional standard lots, is entitled for an extra raffle ticket.
- 3.3. Any trades generated by bonus given by the Company are excluded from the Volume

calculations.

3.4. **Unique Clients Target** is either a new client to the Company or a client who has been reactivated by the Partner. A client cannot be a unique client for more than one Partner. For instance, if a client has registered with the Company following the availability of the Promotion, who has been approved and opened three (3) trading accounts under one or more Partners, and funded all three and traded, for the purposes of this Promotion, the count of the unique clients is 1 (one) on behalf of the Partner assigned to the first (1st) trading account. The other two trading accounts cannot count as Unique Clients

3.5. For the purposes of this Promotion,

(a) Client is a Client who:

- has registered with the Company following the participation of the partner Promotion;
- has an approved wallet with the Company;
- has opened at least one Eligible Trading Account;
- has funded at least one Eligible Trading Account;
- has closed at least one Eligible Trade.

(b) Reactivated Client is a Client who:

- has registered with the Company at least 365 days prior the first day of this promotion;
- has not performed any trading activity or the trading activity was performed 365 days prior the first day of this promotion;
- has opened at least one Eligible Trading Account;
- has funded at least one Eligible Trading Account;
- has closed at least one Eligible Trade.

3.6. **Cash Flow Target** means the internal transfers into the Eligible Trading Accounts from the Client's wallet minus the internal transfers out of the Eligible Trading Accounts during this promotional period.

3.7. **Volume Target** sums up the volume of any Trades that have been closed on the Eligible Trading Accounts.

i. For the purposes of this Promotion, Eligible Trading Accounts are:

- a. MT4 and MT5 live trading accounts apart of Copy Strategy Provider and Copy Follower account and Demo accounts.
- ii. Also, for the purposes of this Promotion, Eligible Trades are:
 - a. closed trades whose open time is after the Company's Partners joined the Promotion and closed within this promotion's completion;
 - b. trades made on Contracts for Differences ("CFDs") on Forex, Gold, Silver and Cryptocurrencies only;
 - c. trades that were open for two minutes or more;
- 3.8. The prizes that are cash amounts will be added to the Partner's approved wallet and can be withdrawn.
- 3.9. The lucky draw will take place at 19th of December.
- 3.10. The Partner can win only one Reward.

4. Rewards

- 4.1. The eligible Partners will be enter into the draw for a chance to win prizes, as detailed below:

- 4.2. The Company shall consider whether the participants fulfil the requirements specified under these Terms and Conditions and should the Partner qualify, the Company will send the applicable award to the Partner.

5. Amendments

- 5.1. The Company reserves the right, at its absolute discretion, to unilaterally modify, change or terminate this Promotion or any of the Terms and Conditions included herein,

at any time without the Partner's consent.

6. Termination

- 6.1. The Company reserves the right to refuse offering the Promotion to any Partner of the Company at its sole discretion without the need to provide any justification.
- 6.2. If the Company suspects and/or has any reason to believe that a Partner has submitted fraudulent details and/or false identification information during the Account Opening Process and/or during the registration for the Promotion, the Company reserves the right at its absolute discretion to disqualify the Partner from this Promotion and/or any other contest or bonus program or promotion offered by the Company.
- 6.3. If the Company suspects or has reasons to believe that any Partner has abused and/or manipulated and/or breached in any way any of the Terms and Conditions of this Promotion and/or any other promotion and/or contest and/or bonus program offered by the Company and/or has not acted in good faith, the Company reserves the right at its absolute discretion to (i) void and/or withhold and/or withdraw any winning prize and/or any payment of the Prizes reached by the Partner and/or (ii) completely disqualify the Partner from this Promotion and/or any other promotion and/or contest and/or bonus Program offered by the Company with immediate effect.
- 6.4. If the Company suspects or has any reason to believe that a Partner has abused and/or manipulated any of the Terms and Conditions of this Promotion and/or any other contest or bonus program or promotion offered by the Company, by hedging his positions internally (using other trading accounts held with Company) or externally (using other trading accounts held with other brokers) and/or has not acted in good faith, the Company reserves the right, at its absolute discretion and without obtaining the Partner's consent, to remove the Promotion from the Partner's Trading Account(s) or from his winning hedged Accounts and/or withdraw and/or withhold any winning prize from the Partner with immediate effect.

7. Dispute

- 7.1. Any dispute arising with or in connection to any of the terms and conditions of this Rewards shall be dealt by the Company as per the Company's Complaints Handling Policy, which is available on the Company's website.

- 8.1. The Partner hereby acknowledges, confirms and accepts to be legally bound by the Terms and Conditions as set out in this Promotion and/or any other legally binding Agreement between him and the Company.
- 8.2. By registering and participating in the Promotion, the Partner confirms that he has read, understood and agreed to be bound by the Terms and Conditions of the Promotion and any other Terms and Conditions of the Company that may apply.
- 8.3. The Partner by participating in the promotion, authorizes the Company to announce interim results and their names on the Company's websites on a regular basis.
- 8.4. By claiming and accepting a prize, each winner agrees for their image and name to be used for marketing and promotional purposes on the Company's website (to be specified and carried out at the sole discretion of the Company).

- 8.9. Close/ suspend all Trading Accounts the Partner has with the Company either temporarily or permanently;
- 8.10. Void all previously credited trading bonuses from the Partner's Trading Accounts with the Company;
- 8.11. Void all transactions carried out, including any pending orders and/or any profits or losses earned.
- 8.12. The Partner acknowledges and understands that where any of the circumstances mentioned in Clause above, occur, the Company will not be liable for any consequences on the Bonus cancellation, including, but not limited to, order(s) closure by Stop Out.
- 8.13. These Terms and Conditions are made in English language. Any other language translation is provided as a convenience only. In the case of any inconsistency or discrepancy between original English texts and their translation into any other language, as the case may be, original versions of English shall prevail.
